The Finance and Audit Committee (Committee) of The North Carolina Partnership for Children, Inc. (NCPC) Board of Directors (Board) met March 8, 2024 via Zoom video conference. # **FYE 2024 Financial Report Review**

# **Review Employee Compensation Policy**

The NCPC Board approved an employee compensation policy on June 18, 2019, that requires the Finance and Audit Committee to review and recommend, annually, any employee compensation allowances. At its September 8, 2023 meeting, the Committee asked for a review of the policy to allow for NCPC to make compensation changes during the fiscal year once the budget is approved. At its January 12, 2024 meeting, the Committee began reviewing the policy to add clarity on being in alignment with the budget under the Delegation of Authority portion of the policy.

The Committee reviewed the highlighted changes adding "in alignment with the budget" in the Delegation of Authority section and Types of Compensation as well as removing the language of

Finance and Audit Committee under each of the Types of Compensation for additional clarity so once the budget is approved by the Board, NCPC may make compensation decisions as long as they don't affect the budget.

A motion was made by Laurie Urland and seconded to recommend Board approval of the Employee Compensation Policy at the March 19, 2024 Board meeting. **Motion carried.**
