Julie Fogg introduced Dan Gerlach, the fundraising consultant who has been hired for a 4-month contract to assist with corporate donors and other fundraising issues.

#### The Duke Endowment Grant Proposal

Julie Fogg provided an update on the Smart Solutions \$1 million grant proposal to integrate collaboration with DSS. The Duke Endowment board meets May 7 to review NCPC's proposal.

# **Fund Development Committee Workplan**

The current workplan is:

- 1. Craft and implement a corporate giving plan to grow NCPC's private funding.
- 2. Create an internal system for managing private dollars through department cross-collaboration.
- 3. Research and provide a donor management/cultivation system as a shared service for all local partnerships.
- 4. Incorporate diversity, equity, inclusion, and belonging (DEIB) into each step of the fund development process.

Julie Fogg provided a brief overview of accomplishments met from the workplan. Tiers for the 2024 Conference will go up to \$15,000 which were previously capped at \$5,000. Julie will send out list of potential long-term corporate support.

There was some discussion over rewording #2 to be more specific in the next plan. Raiser's Edge NXT will go live for all local partnerships on March 20, 2024.

The Board giving requirement was revised to make it more inclusive with objective #4. The Committee will continue to incorporate DEIB into funding requests.

Julie asked for a small workgroup to revise the plan for this fiscal year. Stuart Mills and Dr. Louris Finney are willing to join a small workgroup. Julie will contact them to revise the workplan.
