The Executive Committee (Committee) of The North Carolina Partnership for Children, Inc. (NCPC) Board of Directors (Board) met on October 21, 2024 via Zoom video conference. Chair Bowman called the meeting to order at 2 p.m. The presence of a quorum was established.

#### **Approval of Agenda and Minutes**

# Legislative Agenda of the Report to the General Assembly

As part of legislation, NCPC is required to create a Report to the General Assembly which is always due Dec. 1. The Executive Committee reviewed the legislative agenda section prior to submission. Marta Hester reviewed the four topics that have been completed so far. The Committee agreed to move forward with the legislative agenda by unanimous consent.

# **Debrief Board Annual Meeting and Retreat**

The annual Board Retreat and Annual Meeting was September 16-17, 2024. The Committee discussed the retreat and suggestions and observations for the next Board Retreat in 2025.

- Consider retreat as an extended Board meeting on one day; only 13 Board members attended the retreat, while 22 attended the Board meeting.
- Not have on Monday have later in the week. Will set this date in early 2025.
- Some prefer Thursday evening to Friday early afternoon or Wednesday to Thursday.
- Suggestion to start with Board reception in evening before the one-day retreat and meeting
- Will poll NCPC Board members at a future full meeting.
- Content was good, some would have liked more time with lobbyists. Dan Gerlach was a good facilitator.

#### Hurricane Helene Update

Those from the western part of the state shared their stories. NCPC received \$100,000 unrestricted grant for western North Carolina from The Leon Levine Foundation. Weekly meetings are occurring with early childhood state and regional agencies on Helene recovery efforts. A request has been made to the General Assembly for \$3,275,000 for early care and education center funding for comprehensive needs and use for those most impacted. This is still pending.
